 - b. State Meet Entry Fees: L2-L5 \$65 in gym/\$85 outside facility
L6-10: \$70/\$100 Xcel: BSG \$65 / PD \$75
 - c. State Meet Door Fees: \$30 family 5 (2adults/3 kids) \$10 adults / \$5 kids (3-12) per session
 - d. Compulsory athletes are required to compete in 3 in state meets to be eligible for State meet
 - e. Optional Athletes L6 -10/Xcel– 1 in state meet in required
 - f. L7/L8/Xcel State Teams – gifts will be discussed closer to state meet
 - g. Judges: Compulsory Season, judges must judge 3 meets, 2 of which must be in state to be eligible to judge Compulsory State Meet

- h. Judges: Optional Season, judges must judge 3 meets, 1 of which must be in state to be eligible to judge Optional State Meet
- i. 2015 Optional rated judges must attend a minimum of 1 out of state clinic to be considered for a regional assignment
